

- 4.1 May be used for the following services on board:
 - Fire main and deck-wash
 - Water spray systems
 - Sprinkler and foam firefighting systems
 - Fresh water cooling systems
 - Working air system (10 bar max.)
- 4.2 When the pipes are not under water pressure at all times, the sleeve couplings are to be insulated with Rockwool similarly to the arrangement shown in the fire test No. GV 94.3.2.
- 4.3 The piping with their connections is to be at any time accessible for inspection and maintenance. The piping with their connections may be covered by B and C class division panels where passing through or ending in corridors or in accommodation spaces.
- 4.4 Assembly instructions given by the manufacturer are to be complied with.
- 4.5 The pipes are to be properly secured and protected from mechanical damages.

5. PRODUCTION SURVEY REQUIREMENTS

- 5.1 The pipes and fittings are to be supplied by LOROWERK K. H. Vahlbrauk GmbH & Co. KG. in compliance with the type described in this certificate.
- 5.2 This type of product is within the category HBV of BUREAU VERITAS Rule Note NR320 and as such does not require a BUREAU VERITAS product certificate.
